

Russia's biggest methanol plant to be built in Yakutia

Yakutia Fuel and Energy Company is planning to build a plant for the deep processing of gas valued at more than USD 1 billion. The enterprise's products are expected to be supplied to Northeast Asian countries. The first phase of the plant will have capacity of 1.75 million tonnes of methanol per year.

The new modular plant will be put into operation at the Ozernovskoye gold deposit.
